



Player Terms and Conditions



Acceptance of the online registration confirms your agreement to abide by the following terms and conditions:

- I agree to abide by the Claudelands Rovers Sports Club Player Code of Conduct that can be found at the club or on the clubs website www.rovers.org.nz
- If I infringe the laws of the game, I agree to pay all costs relating to that infringement. Once an infringement is registered with the governing federation, your coach and you will be notified and an invoice will be generated giving you 30 days to pay. Late payment of infringement invoices will result in an administration charge of \$2 per month.
- If any infringement fine or any other costs incurred by you during the season including but not limited to; Club fees, fines incurred, loss or damage of uniform or club equipment etc are not paid by the due date Claudelands Rovers Sports Club reserves the right to pass your debt to a debt collection agency to collect and you will not be able to participate in any future fixtures and any requested transfer will not be approved until all money owing is paid in full. If your debt is passed to a debt collection agency you will be liable for all costs to recover this debt.

Note: The club will assist you and your coach or manager through the disputes process if you have a genuine concern or dispute over an issued infringement invoice or the value of the fine issued by the governing federation.

Infringement costs may be shared by the club or waived at the discretion of the club president.

Clearance Information

I understand that any transfer request to another club will not be approved until:

- a) All financial obligations to Claudelands Rovers Sports Club are cleared by payment and
- b) All Club owned apparel and equipment is returned to the Club in acceptable condition.
